
1. If any Junior Assistant/s as named above in the placement order, on subsequent verification, is found not eligible for such placement, this order will not confer any right on them and their placement on the higher post (made hereby) shall liable to be rescinded in that case. It will be personal responsibility of the Chief Education officer/Drawing and Disbursing Officer to verify particulars of the official/s with reference to his/her original service records/appointment/promotion orders and ensure that the date of 1st appointment/promotion as Junior Assistant as well as other particulars recorded against them (here in above in this order) are correct. Variation if any found should be brought to the notice of this Directorate for further orders. In that case no such Junior Assistant be relieved for their placement on the higher post until further clarification/instructions in the case is sought from this Directorate.
2. The benefit of placement shall not be allowed in case an official be either under suspension or whose suspension period would be still undecided or in the case of an official against whom departmental proceedings/VOK may be pending or whose work and conduct may not be satisfactory.
3. The placement shall be without pre-judice to the final outcome of the case, if any sub-judice /unpugned or pending before the Hon'ble High Court or any other court of law and other orders, if any passed by the competent authority, which are not immediately within the knowledge of this Directorate.
4. That the official must necessarily be holding genuine appointment on substantive basis and un-interrupted service, and shall not falls in the category of fake, fraud, adhoc/contractual appointment/migrant substitute, and are not subject to any criminal proceedings departmental/VOK.
5. The Chief Education officers must ensure that there is nothing adverse against the official from VOK/Crime/Police.
6. The placement order in respect of reserved category aspirants shall be allowed only after production/obtaining verification of original category certificate from the issuing/competent authority.
7. The placement of the officials shall be without pre-judice to the superior claim if any of others.
8. The promotee has not indulged in any immoral act /subversive activities and DDO where they have been working must furnish the said certificate authenticating that the work and conduct of the official has remained satisfactory during working as Junior Assistant.
9. Superior claim vis-à-vis inter-se-placement of the officials for re-determination of seniority in the cadre of Junior Assistants, if any shall be submitted to this Directorate within a period of one month through proper channel.
10.
