**FINAL NOTICE**

Whereas, the Administrative Department vide letter No. Edu-I/77/2017 dated: 17.04.2017, No.Edu-I/56/2017 dated: 17.04.2017 and No. Edu-I/908/2017 dated 15.12.2017 forwarded the selection list of candidates selected as Teachers in District Cadre **Srinagar, Pulwama, Kulgam, Budgam, Baramulla and Anantnag** in pursuance to Advertisement Notification No. 01 of 2012 dated 19.07.2012 (Item No’s. 037, 029, 021, 013, 009 & 001) respectively under Prime Minister’s Special Package for Kashmiri Migrants, for issuance of appointment orders in their favour after fulfilling all formalities and conditions as envisaged under Jammu and Kashmir Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 issued under SRO-412 of 2009 pursuant to the selection made by the J&K Services Selection Board, Srinagar against Notification No. 01 of 2012 dated 19.07.2012;

Whereas, among others, the selection in respect of many candidates in various districts was kept withheld by the SSB and was subsequently released vide various communications conveyed through Administrative Department’s communication No. Edu-I/77/2017 dated 16.04.2018;

Whereas, vide this office notification No. DSEK/Estt/III/B-Trs/PMP/PP/2033-37 dated 22.05.2018 and No. DSEK/Estt/III/B-Trs/PMP/PP/2038-42 dated 22.05.2018, issued through Information Department, these candidates were advised to furnish a copy of their testimonials and undertakings alongwith agreements on the devised format duly attested by the 1st Class Magistrate in terms of SRO-412 of 2009 dated 31.12.2009, in the Directorate of School Education Kashmir, within a period of **Ten days** from the publication of the notification for issuance of provisional appointment orders in their favour;

Whereas, in response to the above notifications dated 22.05.2018, **(5+5) Ten candidates** failed to deposit the requisite papers within the stipulated time period in this Directorate for considering their provisional appointment orders;

Now, therefore, these **Ten (10)** candidates (whose full particulars are reflected below) who have been selected in School Education Department for the post of Teachers for **District Cadre Srinagar, Pulwama, Anantnag, Kupwara, Kulgam and Baramulla** advertised vide Notification No. 01 of 2012 dated 19.07.2012, under **Prime Minister’s Special Package for Kashmiri Migrants** but failed to report Directorate of School Education Kashmir with requisite documents within the stipulated period, are hereby given **final opportunity** to deposit their undertakings forming **Annexure “A” and Agreement** in terms of SRO-412 of 2009, forming **“Annexure B”** (duly attested) by the Judicial Magistrate (1st Class) as well as all original certificates/testimonials with a set of self-attested Xerox copies (**in person**) in the Directorate of School Education Kashmir within **Seven (07) days** from the date of publication of this notification, failing which it shall be presumed that they are not interested to join the Department and the resultant slots shall be filled from the wait list, without any further notice.
