



**AGREEMENT**

WHEREAS the Government has decided to provide employment to unemployed Kashmir migrant youth in terms of Jammu and Kashmir, Kashmiri Migrants (Special Drive) Recruitment Rules, 2009.

WHEREAS vide Order No. \_\_\_\_\_ dated \_\_\_\_\_ The executor has been appointed on probation as \_\_\_\_\_ in the Department \_\_\_\_\_ subject to execution of this Agreement; and inter-alia, on the explicit condition that his appointment as such shall subsist only so long as he serves in the Kashmir Valley; and

WHEREAS the appointee will at no stage seek or opt for transfer outside the Kashmir Valley.
