Fixation/Re-fixation of Combined Seniority at the level of +2 Lecturers/Sr. Lecturers in the School Education Department.

NOTICE

Whereas, J&K Public Service Commission vide No.PSC/DR/Lect10+2/ Geography/2009 dated 16.11.2009 had forwarded the Selection List of 10+2 Lecturers (Geography) pursuant to different notifications including Notification No.07-PSC of 2009 dated 09.03.2009; and

Whereas, in the said selection list, one (01) post under OM category (S.No.08) against Notification No.07-PSC of 2009 dated 09.03.2009 was kept withheld. Accordingly, vide Government Order No.806-Edu of 2009 dated 24.11.2009, appointment order in respect of all the recommended candidates (32 numbers) as 10+2 Lecturers (Geography) was issued; and

Whereas, thereafter, the J&K Public Service Commission vide communication No.PSC/DR/Geography/-2/2009, dated 02.02.2010 informed that the earlier withheld recommendation against S.No.08 under Open category for Notification No.7-PSC of 2009 dated 09.03.2009 has been reviewed and it has been decided to release the said selection of the candidate. Accordingly, the J&K PSC recommended selection of Mr. Raghu Nandan S/o Sh. Ram Krishan R/o VPO Budhi Tehsil and District Kathua against S.No.08 (OM): and

Whereas, purusuant to the abovesaid recommendation and vide Government Order No.256-Edu of 2010 dated 15.03.2010, Mr. Raghu Nandan S/o Sh. Ram Krishan R/o VPO Budhi Tehsil and District Kathua was appointed as 10+2 Lecturer (Geography); and

Whereas, in the meanwhile, the applicant has filed O.A No.61/1353/2022 before the Hon'ble Central Administrative Tribunal and has sought following relief in the matter:

"By way of instant OA, the applicant is seeking a direction to respondents to consider his claim for grant of seniority benefits as Lecturer 10+2 Geography retrospectively from the date the other candidates who participated in the selection process for the post of Lecturer 10+2 Geography pursuant to Notification No.07-PSC of 2009 dated 09.03.2009 have been appointed."

Whereas, the Central Administrative Court vide order dated 27.09.2022 has disposed of the OA with the following directions:-

"....I have considered the submissions made by the Ld. Counsels for both the sides and perused the material on record. Without expressing any opinion on the merits of the case, the O.A. is disposed of at Admission stage with direction to respondents to treat a copy of this O.A. as representation of the applicant and decide it, as per relevant rules, regulations and instructions on the subject, by passing a reasoned and speaking order within a period of four weeks from the date of receipt of a certified copy of this order. A copy of speaking order be communicated to the applicant one week thereafter."

Whereas, in view of the above, the matter has been examined and case referred to the General Administration Department for seeking opinion/advice; and

Administration General Whereas. Department vide U.O No.GAD-SERVOGENL/133/ 2023-02-GAD Dated 11.03.2024 has opined as under;-

Returned: The Department is advised to fix the seniority of the applicant (petitioner) Mr. Raghu Nandan notionally from 24.11.2009 without any monetary benefit as per his order of merit and category and on regular basis prospectively from his actual date of appointment in the School Education Department ordered vide G.O. No.256-Edu of 2010 dated 15.03.2010, subject to the condition that the officers likely to be affected by this action are put to notice, in the first instance."

Whereas, in view of the advice of GAD, the fixation/re-fixation of the seniority of the petitioner, in the seniority list of Lecturer/Sr. Lecturer issued vide Government Order No.22-Edu of 2021, dated 27.01.2021 and Government Order No.183-Eduof 2024 dated 13.03.2024.
