Whereas, remaining un-authorizedly absent from duties attracts action as warranted in terms of Article 128 of J&K Civil Services Rules (Volume I) of 1956, which reads as under:-



Now, before action under **Article 113 of J&K Civil Services Rules (Volume I) of 1956** is initiated against you for remaining un-authorizedly absent from your legitimate duties, an opportunity is hereby provided for hearing you and your statement of defense must reach to this Directorate within **10 days** after issuance of this notice, failing which it shall be construed that you have nothing to say in this regard and proposed action shall be initiated against you without further notice.
