The Chief Education Officers are also enjoined upon to verify the service bio-data of each enlisted trained graduate/trained post-graduate Teachers with reference to their original service records/testimonials/appointment orders and will record the following certificate while furnishing the objections of the combined tentative seniority list in respect of each enlisted Teacher.

- i. that all the enlisted Teachers are holding the genuine appointment in the Department and have been appointed by the competent authority;
- ii. that the appointment as Teacher has been verified and found correct as regularized/appointed Teachers as recorded in the respective column against enlisted Teacher
- iii. that all the enlisted teachers have passed B.Ed. Course through University of Kashmir/Jammu/recognized Universities;
- iv. that nobody Teacher has been left out who was otherwise eligible/due for enlistment of his/her name in the said tentative combined seniority list
- v. that there is no such enlisted Teacher whose date of appointment as regularized Teacher has been recorded as date of engagement as ReT.

A list of **57** trained-graduate/trained post-graduate Teachers which has been expelled from the main seniority list is also send for favour of necessary action and removal of discrepancies as indicated against each enlisted Teacher.
