FINAL NOTICE

Whereas, the Administrative Department vide letter No. Edu-I/77/2017 dated: 17.04.2017 forwarded the selection list of **Two-hundred Sixty-five (265)** candidates selected as Teachers, (**203 for District Cadre Srinagar and 62 for District Cadre Baramulla**) under Prime Minister's Special Package for Kashmiri Migrants, for issuance of appointment orders in their favour after fulfilling all codal formalities and conditions as envisaged under Jammu and Kashmir Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 issued under SRO-412 of 2009 pursuant to the selection made by the J&K Services Selection Board, Srinagar vide letter No. SSB/Secy/Sel/2017/1206-12 dated 25.01.2017 and No. SSB/Secy/Sel/2017/1213-20 dated 25.01.2017 against Notification No. 01 of 2012 dated 19.07.2012, Item No's 037 & 009 respectively;

Whereas, vide various notifications, these selectees were advised to submit the requisite papers in the Directorate of School Education, Kashmir, however, **Twenty-Two** candidates from District Cadre **Srinagar** and **Four** candidates from District Cadre **Baramulla** (whose full particulars are reflected in the Annexure A) failed to do so ;

Whereas, vide this office letter No. Estt-III/B-Trs/7529 dated 21.11.2017, the matter was taken up with the Administrative Department which in turn vide communication No. Edu-I/77/2017 dated 08.01.2018 conveyed authorization for giving final opportunity to such candidates who have failed to join for the post of Teacher, appointed under Prime Minister's Special Package for Kashmiri Migrants, within the stipulated period for District Cadre Srinagar and Baramulla, and thereafter, operate waiting list against the slots, if any, becomes vacant due to non-joining of candidates;

Now, therefore, these **Twenty-six (26)** candidates (whose full particulars are reflected in **Annexure A**) who have been selected in School Education Department for the post of Teachers for **District Cadre Srinagar and Baramulla** advertised vide Notification No. 01 of 2012 dated 19.07.2012, Item No's 037 & 009 respectively under **Prime Minister's Special Package for Kashmiri Migrants** but failed to report Directorate of School Education Kashmir with requisite documents within the stipulated period, are hereby given **final opportunity** to deposit their undertakings forming **Annexure "B" and Agreement** in terms of SRO-412 of 2009, forming "**Annexure C**" (duly attested) by the Judicial Magistrate (1st Class) as well as all original certificates/testimonials with a set of self-attested Xerox copies (**in person**) in the Directorate of School Education Kashmir within **Ten (10) days** from the date of publication of this notification, failing which it shall be presumed that they are not interested to join the Department and the resultant slots shall be filled from the wait list, without any further notice.



Whereas, the Administrative Department vide letter No. Edu-I/287/2014 dated 13.08.2014 forwarded the list of **563** candidates selected as Teachers for District cadre **Kupwara**, pursuant to the selection made by the J&K Services Selection Board, Srinagar vide No. SSB/Sel/Secy/014/6328-34, dated 23.07.2014;

Whereas vide this office Notification No. DSEK/Estt-III/B-Trs./39/2014/Sel-Kup/3657-58 dated:23/08/2014, the selectees were asked to submit their undertakings on the devised format and accordingly provisional appointment orders were issued in their favour;

Whereas, a complaint was received from Services Selection Board vide No. SSB/Sel/Secy/2014/6874-76 dated 09.08.2014 whereunder among others, the ST status of Rifat Aara D/o Ab Khaliq Wani R/o Machil Kupwara figuring at S.No. 12 under ST Category was questioned;

Whereas, the matter was taken up with the Deputy Commissioner Kupwara vide this office letter No. Estt/III/B-Trs/Complaint/SSB/Kup dated 01/11/2014 for obtaining the genuineness of ST Category Certificate;

Whereas, in response, the Deputy Commissioner Kupwara vide letter No. DCK/LRA/17/480 dated 27/01/2017 reported that the ST Certificate under No. SRO-294/08/313/BQ dated 16.07.2008 stand issued in favour of Rifat Aara D/o Abdul Khaliq Wani, however, report is submitted subject to the final outcome report of Crime Branch, Srinagar;

Whereas, vide another communication No. DCK/LRA/17/614 dated 28.09.2017, Deputy Commissioner Kupwara forwarded IGP, State Crime Branch J&K Srinagar's communication No. CHQ/Cit/K-572/15/13305 dated 16.09.2017 whereunder it has been intimated that ST Category Certificate, on the basis of which Rifat Aara D/o Abdul Khaliq Wani stand selected as Teacher in District Cadre Kupwara is found genuinely issued as per the reports obtained during the enquiry;

Whereas, vide this office letter No. DSEK/Estt/III/7614 dated 28/11/2017, the matter was taken up with the Administrative Department for obtaining further instructions with regard to issuance of appointment order in favour of Rifat Aara D/o Ab Khaliq Wani R/o Machil Kupwara figuring at S.No. 12 under ST Category, as the selection list was issued some three years back;

Whereas, in response the Administrative Department vide communication No. Edu-I/287/2014 dated 17.01.2018 conveyed that appointment order may be issued in favour of Rifat Aara D/o Ab Khaliq Wani R/o Machil Kupwara figuring at S.No. 12 under ST Category for the post of Teacher, District Cadre Kupwara;





Consequently, the candidate earlier figuring at S.No. 29 shall now figure at S.No. 28 under OM Category so on and so forth upto S.No. 34 now becoming S.No. 33. The candidate figuring at S.No.1/Wait will now enter into the selection zone and shall now figure at S.No. 34 under OM Category;


