NOTIFICATION

Whereas, the Administrative Department vide letter No. Edu-I/77/2017 dated: 17.04.2017 forwarded the selection list of **Two-hundred Sixty-five (265)** candidates selected as Teachers, (**203 for District Cadre Srinagar and 62 for District Cadre Baramulla**) under Prime Minister's Special Package for Kashmiri Migrants, for issuance of appointment orders in their favour after fulfilling all codal formalities and conditions as envisaged under Jammu and Kashmir Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 issued under SRO-412 of 2009 pursuant to the selection made by the J&K Services Selection Board, Srinagar vide letter No. SSB/Secy/Sel/2017/1206-12 dated 25.01.2017 and No. SSB/Secy/Sel/2017/1213-20 dated 25.01.2017 against Notification No. 01 of 2012 dated 19.07.2012, Item No's 037 & 009 respectively;

Whereas, vide various notifications issued through Information Department, these selectees were informed to submit the requisite papers in the Directorate of School Education Kashmir within a stipulated time and accordingly provisional appointment orders were issued in their favour;

Whereas, as many as **Twenty-two (22)** candidates in District Cadre Srinagar and **Four (04)** candidates in District Cadre Baramulla failed to submit their papers in response to various notifications issued from time to time by the Directorate;

Whereas, the matter was taken up with the Administrative Department vide this office letter No. Estt-III/B-Trs/7529 dated 21.11.2017 and in turn the Administrative Department vide communication No. Edu-I/77/2017 dated 08.01.2018 conveyed approval for operating waiting list against the slots which become available after giving final opportunity to all such candidates who failed to join the Department so far;

Whereas, in pursuance to the instructions of the Administrative Department, all these **Twenty-six (26)** candidates were given final opportunity vide this office notice No. DSEK/Estt/III/B-Trs/PMP/017/381-83 dated 03.02.2018, for submission of their papers, failing which it shall be presumed that they are not interested to join the Department and the resultant slots shall be filled from the wait list, without any further notice;

Whereas, in response to the final notice, only one candidate from District Cadre Srinagar submitted his documents for issuance of provisional appointment order in his favour, and rest **Twenty-five (25)** candidates showed no response and failed to deposit the requisite papers within the stipulated time period, whose District-wise break-up is as under:-

WHEREAS the Government has decided to provide employment to unemployed Kashmir migrant youth in terms of Jammu and Kashmir, Kashmiri Migrants (Special Drive) Recruitment Rules, 2009.

WHEREAS vide Order No: _____ dated _____ The executor has been appointed on probation as _____ in the Department _____ subject to execution of this Agreement; and inter-alia, on the explicit condition that his appointment as such shall subsist only so long as he serves in the Kashmir Valley; and

WHEREAS that the appointee shall be considered for regularization on the basis of his performance and satisfactory completion of period of probation in accordance with aforementioned rules, and

WHEREAS that the appointee agrees to serve in Kashmir Valley and will at no stage opt or seek for transfer outside Kashmir Valley; and

WHEREAS the appointee agrees that in case he migrates again from Kashmir Valley at any stage for any reasons whatsoever, he will stand automatically terminated from the service and shall have no claim against any post under the state; and

WHEREAS if the appointee willfully neglects or refuses to perform his duty in Kashmir Valley the appointing authority shall immediately terminate his service' and

WHEREAS the appointee will at no stage seek or opt for transfer outside the Kashmir Valley.
