**Sub:- Select list of the candidates for the post of Teacher (Education Department) District Cadre Pulwama, pursuant to Notification No. 07 of 2010 under item No. 382.**

**NOTIFICATION**

Whereas, the Administrative Department vide letter No. Edu-I/285/2012 dated 05.09.2012 forwarded list of **139** candidates selected as Teachers for District cadre **Pulwama**, pursuant to the selection made by the J&K Services Selection Board, Srinagar vide Secretary SSB's communication No. SSB/Sel/Secy/012/2137-39 dated 08.08.2012 against notification No. 07 of 2010 dated 12.11.2010 under item No. 382 for further appropriate action;

Whereas, among others a slot at S.No. 11 under OM Category was kept blank by the SSB subject to the verification of the University documents of the candidate through Crime Branch;

Whereas, after chain of communication with the Crime Branch and University of Kashmir, the documents of the candidate namely Neelofer Jan D/o Gh. Mohd Pandit were declared genuine as per the verification reports furnished by University of Kashmir vide No's Verif/Tab/KU/17/559 dated 22.07.2017, No. F(B.Ed-Res-Ver.Tab)KU/17/1606 dated 24.07.2017, No. F (Result-Verf.)/Tab/KU/470-Tab dated 26.07.2017 and No. F (Result-Verf)/Tab/KU/470-Tab dated 22.07.2017, as intimated by the J&K Services Selection Board vide Order dated 11.09.2017;

Whereas, inadvertently, the B.Ed Marks of the candidate have been shown as 738 out of 1000 while as per the documents submitted by the candidate the B.Ed Marks of the candidate were 688 out of 1000 resulting with the merit position of the candidate changed from **S.No. 11 under OM Category to S.No. 20 under OM Category**. Consequently, the candidate earlier figuring at S.No. 12 under OM Category, so on and so forth upto S.No. 19 under OM Category;

Whereas, the Administrative Department vide Government Order No. 03-Edu of 2018 dated 01.01.2018 with reference to General Administration Department's O.M. No. GDC-276/CM/2017 dated 27.12.2017, accorded sanction in relaxation of Sub-Rule (5) of Rule 14 of J&K Civil Services Decentralization and Recruitment Rules, 2010, notified vide SRO-375, dated 21.10.2010 to the revalidation of select list issued by the Services Selection Board, vide its communication No. SSB/Sel/Secy/012/2137-39 dated 08.08.2012 for the post of Teacher District Cadre Pulwama in respect of candidate namely **Neelofar Jan D/o Gh. Mohd Pandit R/o Karimabad, Pulwama** whose recommendation has been released by the SSB vide Order No. 417-SSB of 2017, dated 11.09.2017, again Item No. 382, under OM Category in pursuance to Advertisement Notification No. 07 of 2010, in the main select list, beyond the date of its expiry (viz; 07.08.2013) upto 31<sup>st</sup> January, 2018;
