Whereas, the Administrative Department vide letter No. Edu-I/908/2017 dated 15.12.2017 forwarded the selection list of **Two-hundred Twenty (220)** candidates selected as Teachers, District Cadre Shopian, Srinagar, Pulwama, Kupwara, Kulgam, Budgam, Baramulla, Bandipora and Anantnag in pursuance to Advertisement Notification No. 01 of 2012 dated 19.07.2012 (Item No’s. 033, 037, 029, 025, 021, 013, 009, 005 & 001) respectively under Prime Minister’s Special Package for Kashmiri Migrants (Pending Cases), for issuance of appointment orders in their favour after fulfilling all codal formalities and conditions as envisaged under Jammu and Kashmir Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 issued under SRO-412 of 2009 pursuant to the selection made by the J&K Services Selection Board, Srinagar vide letter No. SSB/Secy/Sel/2017/11258-65 dated: 06.11.2017;

Whereas, among these **220** candidates, selection in respect of **Five (05)** candidates in District Cadre Kupwara was kept withheld by SSB which has now been released vide SSB’s No. SSB/Secy/Sel/Mig/Tr/Kup/13778-80 dated 27.12.2017 and also selection in respect of **Abhinav Zar S/o P.N. Zar figuring at S.No. 58 under OM/HCV Category in District Cadre Anantnag** has been released vide SSB’s communication No. SSB/Secy/Sel/Mig/IV/2017/13092-94 dated 12.12.2017, conveyed by Administrative Department’s communication No. Edu-I/51/2018 dated 23.02.2018;

Whereas, among these five candidates, whose selection stand released vide aforementioned communication, one candidate is figuring at S.No.13 in the Waiting List, as such leaving Four candidates from District Cadre Kupwara and One candidate from District Cadre Anantnag who are eligible to submit the requisite papers in Directorate of School Education Kashmir;


