Sub:- Select list of the candidates for the post of Teacher (Education Department) District Cadre Baramulla, in pursuance to the advertised Notification No's 03 of 2012, 05 of 2013 and 06 of 2013 (Item No's 256, 447 & 401) respectively.

NOTIFICATION

Whereas, the Administrative Department vide letter No. Edu-I/401/2014, dated 07/05/2015 forwarded a copy of communication No. SSB/Sel/Secy/4192-93/015 dated 21.04.2015, No. SSB/Sel/Secy/4137-38/015 dated 18.04.2015, Order No. 211-SSB of 2015 dated 20.04.2015, No. SSB/Sel/Secy/4190-91/015 dated 21.04.2015, No. SSB/Sel/Secy/015/3991-92 dated 11.04.2015 and No. SSB/Sel/Secy/3962-63/015 dated 10.04.2015, with a list of **2+12+2+21+2=39 (Thirty-nine)** candidates respectively (whose selection was previously kept withheld by the SSRB) for further appropriate action, as the SSRB now recommended their selection as Teacher;

Whereas, vide SSB's order No. 211-SSB of 2015 dated 20.04.2015, the selection in respect of **Two (02)** candidates has been released, however, there is some discrepancy with regard to Serial Number of **One (01)** selectee which needs further clarification from the Administrative Department/SSB;

Whereas, among these **39** selectees, **Thirteen (13)** candidates belong to **HC** Category and their provisional appointment can be considered only after genuineness of their Handicapped certificates is ascertained from the concerned issuing authority and **One (01)** candidates makes place in the wait list and as such only **24** candidates whose full particulars are appended herewith as "**Annexure A**" can be considered for provisional appointment at this stage;

Now, therefore, these **24** candidates are hereby advised to deposit their undertakings (duly attested) by the Judicial Magistrate (1st Class) on the devised format appended herewith as "**Annexure B**" in the Directorate of School Education Kashmir and also deposit their original qualification and category certificates before the Chief Education Officer Baramulla for seeking verification/authentication of these certificates from the concerned issuing authorities within Seven days from the date of publication of this notification.

This notification is without prejudice to the Court cases, if any pending in the Hon'ble Court which are not immediately without the knowledge of this Directorate.


No such undertakings shall be entertained after expiry of the stipulated time frame.


