## NOTIFICATION

Whereas, the Service Selection Board vide letter No. SSB/Secy/Sel/2017/1258-65, dated. 27/01/2017 issued select list for the post of "Lab. Assistant" (Education Department) under Hon'ble Prime Minister's Special Package for Kashmiri Migrants, District Cadre Pulwama and Ganderbal, advertised vide notification No. 01 of 2012 under item No. 030 and 018 respectively;

Whereas, this office vide Notification No. DSEK/NT/Mig-Retire/26-31/SF/1097-98, dated. 30/06/2017, appeared in press through information department on 05/07/2017, directing the selectees to deposit the requisite original as well as self attested certificates/testimonials in this Directorate within (15) days from the date of publishing of the notification in the press and the selectees who have deposited their testimonials/documents in this Directorate, their appointment orders have been issued accordingly;

Whereas, among others the selection of the candidates namely Sanjay Hangloo S/O Makhan Lal Hangloo figuring at S.No. 01 under OM category District Pulwama, and Shivani Bhat D/O Tej Krishan Bhat figuring at S.No. 01 under OM category District Ganderbal was kept withheld by SSB and was subject to production of original Migrant Certificates from the competent authority before the Service Selection Board;

Whereas, the Service Selection Board has issued an order bearing No. 26-SSB of 2018, dated. 04/01/2018, conveyed by Admn. Deptt's vide letter No. Edu-I/78/2017, dated. 16/04/2018 reads as:-

1. "Whereas, the Board issued final select list for the post of "Lab. Assistant" (Education Department) under Hon'ble Prime Minister's special package for Kashmiri Migrants, District cadre Pulwama advertised vide notification No. 01 of 2012 under item No. 030 and recommended the said select list to the Revenue Department vide this office letter no. SSB/Secy/Sel/2017/1258-65, dated. 27/01/2017 for further course of action; and
2. Whereas, among others the selection of the candidate namely Sanjay Hangloo S/O Makhan Lal Hangloo figuring at S.No. 01 under OM category has been kept withheld and is subject to production of original Migrant certificate from competent authority; and
3. Whereas, the said candidate has not submitted his documents in order to release the recommendation for the above said post; and
4. Whereas, the above said candidate was accordingly informed vide this office circular No. SSB/Adm/2017/ 7232-37 dated. 22/08/2017 to submit his pending documents for release of his recommendation; and
5. Whereas, the said candidate was also called during the special drive conducted on 5<sup>th</sup>, 6<sup>th</sup> and 7<sup>th</sup> September, 2017 notified vide No. SSB/Adm/2017/7806-09 dated. 30/08/2017 for release of his recommendation, but he did not appeared before the Board on scheduled dates; and
6. Whereas, a final notice was issued under endorsement No. SSB/Sel/Secy/2017/13469-71, dated. 20/12/2017 to submit his relevant papers within five (05) days from the date of issuance of this notice, otherwise he will forfeit his selection.

Therefore, in view of the aforementioned circumstances, the withheld selection of the candidate namely Sanjay Hangloo S/O Makhan Lal Hangloo figuring at S.No. 01 under OM category has been cancelled/ withdrawn abinitio. Consequently the candidate earlier figuring at S.No. 02 under OM category shall now figure S.No. 01 under OM category and the candidate earlier falling in waiting list at S.No. 01 shall now enter into selection zone at S.No. 02 under OM category".

Whereas, the Service Selection Board has also issued an order bearing No. 35-SSB of 2018, dated. 08/01/2018, conveyed by Admn. Deptt's letter No. Edu-I/78/2017, dated. 16/04/2018 reads as:-

1. "Whereas, the Board issued final select list for the post of "Lab. Assistant" (Education Department) under Hon'ble Prime Minister's special package for Kashmiri Migrants, District cadre Ganderbal advertised vide notification No. 01 of 2012 under item No. 018 and recommended the said select list to the Revenue Department vide this office letter no. SSB/Secy/Sel/2017/1258-65, dated. 27/01/2017 for further course of action; and
2. Whereas, among others the selection of the candidate namely Shivani Bhat D/O Tej Krishan Bhat figuring at S.No. 01 under OM category has been kept withheld and is subject to production of original Migrant certificate from competent authority; and



### AGREEMENT

THIS AGREEMENT is made on \_\_\_\_\_ day of \_\_\_\_\_ between the Govt. of Jammu  
and Kashmir through the appointing authority of the one part and Sh/Smt/\_\_\_\_\_/\_\_\_\_\_ S/O,  
D/O, W/O \_\_\_\_\_ residing at \_\_\_\_\_ (hereinafter called as the contracting party) of the  
other part; and

WHEREAS the Government has decided to provide employment to unemployed Kashmir migrant  
youth in terms of Jammu and Kashmir, Khasmiri Migrants (Special Drive) Recruitment Rules, 2009.

WHEREAS vide Order No. \_\_\_\_\_ dated \_\_\_\_\_ The executor has been  
appointed on probation as \_\_\_\_\_ in the Department \_\_\_\_\_ subject to execution  
of this Agreement; and inter-alia, on the explicit condition that his appointment as such shall subsist only so long as he  
serves in the Kashmir Valley; and

WHEREAS that the appointee shall be considered for regularization on the basis of his performance  
and satisfactory completion of period of probation in accordance with aforementioned rules, and

WHEREAS that the appointee agrees to serve in Kashmir Valley and will at no stage opt or seek for  
transfer outside Kashmir Valley; and

WHEREAS the appointee agrees that in case he migrates again from Kashmir Valley at any stage for  
any reasons whatsoever, he will stand automatically terminated from the service and shall have no claim against any  
post under the state; and

WHEREAS if the appointee will fully neglects or refuses to perform his duty in Kashmir Valley the  
appointing authority shall immediately terminate his service and

WHEREAS the appointee will at no stage seek or opt for transfer outside the Kashmir Valley.

Now, therefore, I accept the said terms and conditions of appointment.
