**NOTIFICATION**

Whereas, the Administrative Department vide letter No. Edu-I/401/2014 dated 02.02.2015 forwarded the list of 800 candidates selected as Teachers for District Cadre Baramulla pursuant to their selection made by the J&K Services Selection Board, Srinagar vide No. SSB/Sel/Secy/2014/2955-61 dated 19.12.2014;

Whereas vide this office Notification No. DSEK/Est/III/B-Trs/05/2015/Sel-Bla/4567-68 dated 05.03.2015 followed by many such notifications published from time to time, these selectees were advised to submit their undertakings on the devised format and accordingly provisional appointment orders were issued in their favour;

Whereas, as many as **Fifty (50)** candidates under different categories/notifications either failed to deposit their undertakings or not joined in the concerned CEO's Office within the stipulated time period and accordingly the matter was taken up with the Administrative Department this office letter No. DSEK/III/05/2015/65558 dated 16.07.2015 for seeking necessary instructions and in turn this office was authorized to operate wait list Administrative Department vide letter No. Edu-I/401/2014, dated 07.08.2015;

Whereas, the Chief Education Officer, Baramulla vide fresh letter No. CEO/Bla/Estt/Tr/30389 dated 10.12.2015 and No. CEO/Bla/Estt/Tr/30711 dated 16.12.2015 intimated that **Two (02)** candidates namely **Showket Ahmad Tantray S/o Abdul Rasheed Tantray R/o Rebon Rafiabad The Rohama District Baramulla** figuring at S.No. 3 to Annexure of DSEK Order No. 2162-DSEK of 2015Dt: 16.07.2015 and **Javeed Ahmad Lone S/o Manzoor Ahmad Lone R/o Wadoora Payeen Sopore, District Baramulla** figuring at S.No. 15 to the Annexure of Order No. 1315-DSEK OF 2015 Dt: 02.05.2015 under **OM Category**, have failed to join the Department so far and have furnished their undertakings (duly countersigned by the 1<sup>st</sup> Class Magistrate) to the effect that they don't have any objection if the next in merit candidates are considered against their posts;

Whereas, due to non-joining /cancellation of provisional appointment order of above named two candidates vide order No. 2952-DSEK of 2015 dated 18.12.2015, two vacancies under OM Category against Item 447, 05 of 2013, became available for operation of wait list;

Whereas, the Administrative Department vide letter No. Edu-I/401/2014 dated 17.12.2015 forwarded a copy of representation of **Shahid Majeed Monga S/o Abdul Majeed Monga R/o Zehampora Boniyar Baramulla** alongwith an undertaking of **Abdul Gani Sheikh S/o Gh. Mohd Sheikh R/o Village Gantamulla Bala The & District Baramulla** figuring at S.No. 32 under RBA Category against item No. 447 (05 of 2013), (whose recommendation has been kept withheld by the SSRB for want of production of valid category certificate) to the effect that he is not willing to join the Education Department and shall not claim for the same in future;

Whereas, due to withdrawal of candidature by **Abdul Gani Sheikh S/o Gh. Mohd Sheikh, Shahid Majeed Monga S/o Abdul Majeed Monga R/o Zehampora Boniyar Baramulla** figuring at S.No. 5/Wait under RBA Category against item No. 447 (05 of 2013) makes it to the selection zone;

Whereas, vide another communication, the Administrative Department vide No. Edu-I/401/2014 dated 18.12.2014 forwarded SSB's Order No. 534-SSB of 2015 dated 12.12.2015 whereunder Two slots under RBA Category in item 401 (06 of 2013) have been placed at the disposal of this office for utilization from wait list under the same category and item. The change that lead to the availability of two slots as described by SSB is reproduced as under:-

"Whereas, while issuing the said list, slots at S.No. 80 and 81 under RBA Category of item 401(06 of 2013) were kept blank/reserved for want of certain clarification;

Whereas, out of the aforesaid slots, one slot under RBA category of item No. 401 (06 of 2013) stands already utilized for the candidates namely Waheed Ahmad Khan, consequent upon deduction of 02 posts (M.Phil points) from his overall merit. As a result, in the selection list under RBA Category of item No. 447 (05 of 2013) following change has taken place:

S.No. 44 now becomes S.No. 43, S.No. 45 now become S.No. 44 so on and so forth until S.No. 58 now become S.No. 57.

The candidate figuring in the selection zone at S.No. 3 under RBA category of item 401 (06 of 2013) namely Gh. Mohamad Lone having got total merit 62.2472 will move to item No. 447 (05 of 2013) at S.No. 58 under RBA Category. Thereby creating another slot/vacancy under RBA Category in item No. 401 (06 of 2013)

In view of the situation enumerated above, the two vacant slots under RBA Category of item No. 401(06 of 2013) will be occupied/filled up by the candidates already placed in the waiting list under RBA Category in item 401 (06 of 2013)".

Whereas, the recommendation in respect of S.No. 3/Wait against item 401 (06 of 2013) was earlier kept withheld by the SSB and later on released vide No. SSB/Sel/Secy/015/3302-03 dated 16.03.2015 which was received from Administrative Department vide letter No. Edu-I/401/2014 dated 31.03.2015;

Now, therefore, in view of the above circumstances, the below named Five (05) candidates who are in queue in wait list and whose particulars are reflected below are hereby informed to deposit their undertakings duly attested by the 1<sup>st</sup> Class Judicial Magistrate on the devised format "Annexure A" alongwith all original certificates in the Directorate of School Education Kashmir within Seven days from the date of publication of this notification.
