NOTIFICATION

Whereas, the Administrative Department vide letter No. Edu-I/77/2017 dated: 17.04.2017 forwarded the selection list of candidates selected as Teachers, in **District Cadre Srinagar/Baramulla** under Prime Minister's Special Package for Kashmiri Migrants, for issuance of appointment orders in their favour after fulfilling all codal formalities, however, selection in respect of many candidates was kept withheld by the SSB for want of certain clarifications/fulfillment of requisite documents;

Whereas, the Administrative Department vide letter No. Edu-I/77/2017 dated: 09.03.2018 and No. Edu-I/56/2017 dated 28.03.2018 forwarded SSB's communication No. SSB/Secy/Sel/Mig/Sgr/XII/12167-69 dated 24.11.2017, No. SSB/Secy/Sel/Mig/Sgr/IX/2017/12162-69 dated 24.11.2017, No. SSB/Secy/Sel/Mig/Sgr/XII/12631-33 dated 28.11.2017, No. SSB/Secy/Sel/2017/13468 dated 20.11.2017 and Order No. 664-SSB of 2017 dated 22.11.2017 whereunder selection in respect of **Five** candidates including one candidate who makes place in the waiting list at S.No. 27 has been released which was also kept withheld by the SSB;

Whereas, in terms of SSB's Order 664-SSB of 2017 Dt: 22.11.2017, **Two** points of PG Degree have been deducted from overall merit of **Amit Bhat S/o Moti Lal Bhat** who was earlier figuring at **S.No. 54** and has been placed at **S.No. 79** and consequent upon S.No 55 shall now figure at S.No. 54 so on and so forth upto S.No. 79;

Now, therefore, following **Four (04)** candidates who have been selected in School Education Department for the post of Teacher for District Cadre **Srinagar** in pursuance to SSB's Advertisement Notification No. 01 of 2012 dated 19.07.2012, against **Item No. 037** under **Prime Minister's Special Package for Kashmiri Migrants** and whose recommendations stand now been released vide above referred communication of the Administrative Department, are hereby informed to deposit their undertakings forming **Annexure "A" and Agreement** in terms of SRO-412 of 2009, forming **"Annexure B"** (duly attested) by the Judicial Magistrate (1st Class) as well as all original certificates/testimonials with a set of self-attested Xerox copies (in person) in the Directorate of School Education Kashmir within **Ten (10) days** from the date of publication of this notification.


