After expiry of the stipulated period of 10 days, the Chief Education Officer concerned will furnish seniority list duly updated including that of SIE/DIET's with the following certificates enabling this Directorate to process the declaration of the seniority list as final in terms of Rule 24 of Classification, Control And Appeal Rules 1956.

- i) That the officials listed in the tentative Seniority list have genuine appointment on substantive basis, any official having criminal case in VOK, crime/Court or departmental inquiry be conspicuously noted in the remarks column mentioning the FIR No. etc. In addition to furnish full details of such cases separately
- ii) That none of the listed officials belong to any other department other than the School Education Department.
- iii) That all the officials mentioned in the list are in active service and no official is on long leave or is unauthorizedly absent.
- iv) That none of the officials in the list has disputed eligibility/fake appointment.
- v) Valid category certificate in respect of incumbents belonging to reserve categories duly attested by CEO concern should also be attached with the list.
