Sub:- Select list of the candidates for the post of Teacher (Education Department) District Cadre Kupwara, in pursuance to the advertised Notification No's 03 of 2012, 05 of 2013 and 06 of 2013 (Item No's 306, 462 & 442).

NOTIFICATION

Whereas, the Administrative Department vide letter No. Edu-1.05.2015 dated 13.04.2015 and No. Even dated 07.04.2015 forwarded Secretary SSB's communication No. SSB/Sel/ Secy/015/3611-12 dated 01/04/2015 and No. SSB/Sel/ Secy/015/3613-14 dated 01/04/2015. No. SSB/Sel/Secy/015/3300-3301 dated 16/03/2015 and No. SSB/Sel/Secy/015/ 3298-99 dated 16/03/2015 with a list of **(7+2+16+11=36) Thirty-Six** candidates respectively (whose selection was previously kept withheld by the SSRB) for further appropriate action, as the SSRB now recommended their selection as Teacher;

Whereas, among these 36 selectees, only 34 candidates whose full particulars are reflected as "Annexure A" were found upto the mark and in respect of one candidate genuineness of RBA Category is to be ascertained from the issuing authority in pursuance to the instructions of the SSB and the other candidate makes his place in the wait list.

Now, the **Thirty-Four** candidates whose particulars are appended herewith as "Annexure A" are hereby informed to deposit their undertakings duly attested by the 1st Class Judicial Magistrate on the devised format "Annexure B" in the Directorate of School Education Kashmir and also deposit their original qualification and category certificates before the Chief Education Officer Kupwara for seeking verification/authentication of these certificates from the concerned issuing authorities within **Seven days** from the date of publication of this notification.

No such undertakings shall be entertained after expiry of the stipulated time frame.


This notification is without prejudice to the Court cases, if any pending in the Hon'ble Court which are not immediately without the knowledge of this Directorate.
