Whereas, in compliance to Hon'ble Court directions passed in SWP No. 1151/2014 and CMP No. 1849/2014 titled Muthar Rashid Vs State & Ors. the provisional appointment in respect of Asif Ahmed Shah S/o Wali Mohammad Shah R/o Batapora Hazratbal, Srinagar figuring at S.No. 27 (tail end of select list) under OM Category against notification No. 06 of 2013 (Item No. 457) was not given effect:
