The In-Situ promotion cases of teaching/Non-teaching officials appearing in the Annexure of this letter could not be settled due to clarification/ documents as indicated against each.


You are accordingly requested to furnish clarification / documents, **in respect of Divisional Cadre posts only** adopting the following procedure.

Moreover, you are requested to furnish fresh attested Xerox copy of service book with upto date Service verification certificate in each observation case with your clear recommendations instead of simply endorsing the report of DDO concerned.
