Whereas appointees of **23/11/1996** as Teachers have been considered for their promotion as Masters/Head-Teachers under **Social Caste** category vide above referred promotion order.

Whereas upon examination of the issue by this office, it came to the fore that the Teachers in question have erroneously been promoted under Schedule Tribe category whileas they actually belong to Social Caste category as such they can be considered for their promotion as Masters/Head-Teachers in accordance of their eligibility/seniority at the appropriate time/turn. The promotion order issued in their favour under above referred order needs to be rescinded.

Now, therefore, sanction is hereby accorded to the cancellation of promotion as Masters/Head-Teachers issued vide Order No. 2637-DSEK of 2009 Dated 02/23/2009 in favour **06 (six)** trained-graduate/post-graduate Teachers as named in para 01 above ab initio
