Subject:- Placement of eligible trained-graduate / trained post-graduate Teachers for promotion as Incharge Masters / Head-Teachers.

**ORDER NO. 1327-DSEK of 2013
DATED 20 / 05 / 2013**

Whereas, 1500 eligible trained-graduate/trained post-graduate Teachers were placed as Incharge Masters/Head-Teachers in their own pay and grade as a stop gap arrangement, pending ratification of the DPC and verification of service bio-data and other eligibility as required for such placement by the Chief Education Officer/Drawing and Disbursing Officer vide this office Order No.928-DSEK of 2013 Dated 30/03/2013;

Whereas, the Chief Education Officer./Drawing and Disbursing Officer concerned were impressed upon to give wide publicity to the placement order for inviting objections which was scheduled to reach this Office in a consolidated manner within 15-days from the date of placement order;

Whereas, after expiry of the given time for receiving objections, some Chief Education Officers failed to furnish the consolidated objections within the stipulated time and accordingly a circular instructions were issued to all Chief Education Officers to furnish objections if received by them in a consolidated manner with the requisite documents/certificates for the same vide this Office No. Estt-III/NG/Prom/2013/86-100 Dated 17/04/2013;

Whereas, all the Chief Education officers furnished the objections with regard to correction/insertion of particulars and inclusions in the placement order on the same day viz 06/05/2013;

Whereas, on examination of these objections furnished by the concerned Chief Education Officers in a consolidated manner it has been observed that the particulars of some officials who have been included in the placement order and needs to be corrected besides deletion of 34 officials and furnishing of documents in respect of 03-officials including in the placement order as detailed below:-

Whereas, on examination of these objects punished by concerned Chief Education Officers in a consolidated manner (170) representations have been received for inclusion in the placement order/seniority list;

Whereas, out of 170 cases recommended by Chief Education Officers for inclusion in the placement order (137) cases were eligible for inclusion in the placement order of Masters/Head-Teachers as per the recommendations of Chief Education Officers as per the District-wise break-up as under:-

Whereas consequent upon placement of trained-graduate/trained post-graduate Teachers as Incharge Masters/Head-Teachers issued under No. 928-DSEK of 2013 Dated 30/03/2013, (137) drop-out cases were examined and found eligible for inclusion in the placement order in addition to above.

Now, therefore, without prejudice to inter-se seniority, out come of Court case pending before any Hon'ble Court, sanction is hereby accorded to the placement of trained-graduate/trained post-graduate Teachers as Incharge Masters/Head-Teachers in their own pay and grade as a stop-gap arrangement in view of academic necessity on the available posts in the Districts to be ordered separately as per **Annexure** to this Order, pending ratification by the Departmental Promotion Committee and verification of service bio-data and other eligibility as required for such placement by the concerned Chief Education Officer / Drawing and Disbursing Officers and subject to the following conditions:-

- that in case of any discrepancy in the service particulars of any official is reported any official is found not to be eligible for such placement, this order will not confer any right upon the official and the placement shall be deemed to have been rescinded abintio in that case;
- that in case any eligible Teacher does not found his name included in the said placement order he/she could be considered also giving the effect of placement from the same date his/her counterparts were considered as such;
- that the placement of Teachers as Incharge Masters/Head-Teachers made under this Order is without prejudice to the superior claims if any. The inter-se position assigned to the officials in the Annexure to this Order, or other orders issued from time to time, shall be liable to be re-determined separately on facts/merits/superior of each case;
- that in case of any adverse report from Vigilance Organization, the placement of the concerned Teachers shall be cancelled without prior notice;
- that the officials must necessarily be holding substantive appointment and uninterrupted service, it must be ensured that none of the officials in the list is working as Migrant substantive/un-recognized/FAT/Fake/Adhoc basis. The benefit of placement shall not be allowed in case of such a Teacher who is under suspension or against whom departmental proceedings may be pending or whose work and conduct is not be satisfactory;
- that the officials must have passed B.Ed./M.Ed. examination before the date of placement through a **Recognized University** after observing all departmental formalities
- that the placement shall be without prejudice to the final outcome of the court case, if any pending before any subordinate court or the Hon'ble High Court and other orders, if any passed by the competent authority which are not immediately within the knowledge of this Directorate;
- that the posting orders will be issued in respect of only those officials in whose case all above conditions are fulfilled by the respective Chief Education Officers/Drawing and Disbursing Officers;
