Subject:- Final Show-cause Notice.

Whereas, this office received a complaint from Teachers of Zone Beerwah regarding misappropriation of funds in Zone Beerwah;

Whereas, the complaint was forwarded to ADVO, Budgam vide No. DSEK/IMW/Bud/12/2015/377 Dated:05/03/2015 for conducting enquiry into the matter;

Whereas, the ADVO Budgam submitted his enquiry report vide No. CEOB/DEPO/15/4316 Dated: 06/05/2015 which reveals that you have not maintained the records/accounts properly which has resulted in a number of irregularities in the ZEO Office Beerwah;

Whereas, the report further reveals that you have concealed the facts / records and deceived the DDO concerned;

Whereas, the ZEO Beerwah vide his letter No. ZEO/B/Estt/15/002-006 Dated: 04/04/2015 claims categorically that you have deceived him by presenting wrong figures of payments;

Whereas, the ZEO Beerwah vide his letter No. ZEOB/Estt/15/015-019 Dated: 08/04/2015 reports that you are habitual cheater, corrupt and use rough and un-parliamentary language;

Whereas, you have allegedly distorted figures / records resulting in release of excess payments in the construction of SSA buildings;

Whereas, you have managed release of Grade Pay of Rs 4200 instead of permissible Rs 2800;

Whereas, you have caused double drawl of salary in favour of Mr. Gh. Mohammad Dar, Master, Zone Beerwah;

Whereas, the records further reveal that you have transgressed / trespassed the norms during your official duty which does not behoove an official;

Whereas, you were provided a chance of being heard and clarify your position by virtue of a show-cause Notice served to you vide this office No. DSEK/IMW/Bud/2015/22-23 Dated: 08/01/2016;

Whereas, perusal of your reply to the Show-cause Notice dated 08/01/2016 reveals that you have failed to produce substantial proof / evidence / reply to the allegations leveled against you.

In view of the above, you are provided a final chance to show cause as to why action as warranted under rules shall not be initiated against you.

Your reply should reach this office within seven days lest it shall be presumed that you have nothing to say in your defense and action as warranted under rules shall follow without any further notice.
