
'Absence without leave or after the end of leave involves loss of appointment'.

Show Cause Notice

Whereas, the CEO Budgam vide his communication No. CEOB/Estt/2019/ 18298 dated: 05/11/2019 reported that you had applied for leave without pay for a period of one year w.e.f. 15/01/2020 to proceed United Kingdom, which was not sanctioned in your favour, and

Whereas, without obtaining prior permission and sanction of leave from the competent authorities you left the station and proceeded to United Kingdom in violation of rules/guidelines governing on the subject, and

Whereas, the records reveal that you have proceeded outside the country without obtaining proper permission from the competent authorities viz on 23/02/2018 to 23/02/2019 and on 08/03/2019 to 30/07/2019, and

Whereas, leaving the station by a Government Servant without obtaining proper station leave permission from the competent authority is in violation of circular instructions issued by the Finance Department on the subject under their No. A/46(2017)-I-86z dated: 21/02/2019 and as such attracts action as warranted in terms of article 128 of J&K Civil Services Rules (Volume I) of 1956, which reads as under:-

'Absence without leave or after the end of leave involves loss of appointment'.

Whereas, a matter was enquired by the Joint Director (C) on 02/03/2020 and you failed to report before the Enquiry Officer;

Whereas, you were provided an opportunity to present yourself before this Directorate along with your statement of defense within seven days from the date of issuance of the said notice vide No. DSEK/Estt/III/B-Trs/SLP/19/2019/SF/10145 dated: 07/12/2020, which you again failed;
