Show-cause Notice

Whereas, the Govt. Schools mentioned in Annexure – A registered dismal performance in the annual results of Secondary Examination (10th) Session-2014-15;

Whereas, the Heads / subject teachers of these Institutions were given opportunity to improve their results in Annual-2015-16 results;

Whereas, a circular No. DSEK/CEW/Set/15/667 Dated: 26/08/2015 was issued to desist from detaining the students from appearing in the Secondary Examination (Annual);

Whereas, the State Board of School Education provided RR of the schools perusal of which revealed that these institutions have gone for detaining the students and thus violating the standing circular instructions;


Whereas, the result calculated on the basis of RR shows again dismal performance and depicts deplorable picture of the institutions;

Whereas, these institutions have repeatedly shown poor / dismal performance in the 10th class Annual Examinations (Session 2014 & 2015) and have detained a good number of students from appearing in the said examination;

Whereas, such misleading act / faulty procedure has brought the Department to disrepute and has resulted into the wastage of a good chunk of human resource;

Whereas, the efforts made by the Department to get the system on the rails are crashed by the gross negligence / dereliction of duties by the Heads of these institutes for which stringent action as warranted under rules becomes inevitable.

In view of the above, Heads of these Schools (List enclosed) are asked to show cause as to why action as warranted under rules shall not be initiated against them. The reply should reach this office within seven days lest it shall be presumed that they have nothing to say in their defense and action as warranted under rules shall follow without any further notice.
