Re-fixation of seniority of Sh.Varinder Kumar-I, Senior Lecturer, HSS Bharakh, Reasi—Notice inviting objections, if any.

NOTICE

Whereas, the final seniority list of Senior Lecturers was issued by this department vide Government Order No. 270-Edu of 2013 dated 12-03-2013; and

Whereas, Mr.Varinder Kumar-I was regularized as Lecturer (Physics) w.e.f. 12-04-1993 vide Government Order No. 851-Edu of 1999 dated 25-06-1999 but while incorporating his name in the seniority list of +2 Lecturers, his date of confirmation/regularization was inadvertently shown as 7-9-1993 instead of 12-04-1993 and his seniority was accordingly fixed at seniority No. 361 in the seniority list of +2 Lecturer issued vide Government Order No. 163-Edu of 2006 dated 15-03-2006; and

Whereas, on the basis of seniority list of +2 Lecturers, Sh.Varinder Kumar-I was placed as Senior Lecturer vide Government Order No. 129-Edu of 2011 dated 24-2-2011 and his seniority was fixed at serial No.1108 in the seniority list of Sr. Lecturers issued vide G.O.No. 270-Edu of 2013 dated 12-03-2013; and

Whereas, Mr.Varinder Kumar-I has represented this department for refixation of his seniority as Lecturer on the grounds that his date of confirmation has been wrongly shown as 07-09-1993 instead of 12-04-1993 in the seniority list of Lecturer +2 issued vide G.O.No. 163-edu of 2006 dated 15-03-2006; and

Whereas, the case was examined in this department and vide G.O.No. 156-Edu of 2014 dated 18-02-2014, his seniority was re-fixed at S.No.188-A instead of seniority no. 361 in the seniority list of +2 Lecturers issued vide G.O.No. 163-Edu of 2006 dated 15-03-2006; and

Whereas, the seniority position of Sh.Varinder Kumar-I has now been changed at the Lecturer level, so it is also required to be changed at the level of Senior Lecturer; and

Whereas, the case has been examined further in the department and it has been observed that the seniority of Mr.Varinder Kumar-I, Sr.Lecturer, HSS Bharakh, Reasi is required to be re-fixed at S.No.1018-A instead of 1108 as per the following service particulars:-


