Whereas, the Administrative Department vide letter No. Edu-I/287/2014-II dated 09.07.2015 forwarded Secretary SSB's communication No. SSB/Sel/Secy/5318-20/2015 dated 02.06.2015, wherein the recommendation in respect of **Shazia Khan D/o Liyaqat Ali Khan** figuring at **S.No. 322 under OM/HCL** (falling next in merit under the said Category) has been conveyed for the post of Teacher District Cadre Kupwara pursuant to advertisement notice No. 07 of 2010 dated 12.11.2010, Item No. 387 subject to verification of production of valid HCL certificate and production of bonafide certificates/validity of Graduation and PG Degree.

Whereas, the Administrative Department vide another letter No. Edu-I/287/2014-II dated 28.10.2015, forwarded Secretary SSB's communication No. SSB/Sel/Secy/2015/10559-61 dated 09.10.2015 wherein her recommendation has been released. However further action shall be taken after seeking the handicapped status of the candidate.

Whereas, the matter was taken up with the Chief Medical Officer Kupwara vide letter No. Estt/III/B-Trs/66701 dated 31.10.2015, for seeking report/authentication of her Disability Certificate;

Whereas, Chief Medical Officer Kupwara vide his letter No. CMOK/Estt-II/4410 dated 02.11.2015 intimatead that the Disability certificate bearing No. CMOK/60 dated 02.02.2001 has been verified and found correct as per records. Moreover, with regard to status of disability it has been intimated that it is life long.

Now, in terms of recommendations of SSB/Administrative Department, **Smt. Shazia Khan** (whose full particulars are reproduced below) is hereby informed to deposit her undertakings duly attested by the 1st Class Judicial Magistrate on the devised format "**Annexure A**" in the Directorate of School Education Kashmir alongwith all original certificates, within **Seven days** from the date of publication of this notification.
