
Sub: Tentative seniority list of Junior Stenographers.

The Chief Education Officer concerned will furnish the following certificates in favour of the concerned Junior Scale Stenographers, to enable this Directorate to process the issue, for declaring the seniority list as final:

- i) That none of the incumbent ~~except those~~ mentioned in the seniority list are under suspension or contemplated on any charge of any nature and that no investigation/inquiry is pending and suspension period was decided/yet to be decided.
- ii) That none of the listed officials belong to any other department other than the School Education Department.
- iii) That all the officials mentioned in the list are in active service and no official is on long leave.
- iv) That none of the officials in the list has disputed eligibility/fake appointment.
