Whereas, the issue for the confirmation of four (04) senior most Head Assistants (Look-after Section Officers) after having completed their eligible services of 03 three years as Head Assistants required for Promotion as Section Officer in terms of SRO 308 Dated 16-10-2008, was placed before Divisional Departmental Promotion Committee held on 23-11-2024, and;

**Whereas**, the DDPC after threadbare discussion and scrutiny of the documents agreed to the confirmation of Three (03) Look-after Section Officers as Section Officer and desired to seek some of the documents in respect of one (01) Look-after Section Officer from the concerned CEO and the case to be placed in next DDPC.

- 4. That the official must necessarily be holding genuine appointment on substantive basis, in the department and has been appointed/ selected by the Competent Authority and has uninterrupted service, and shall not fall in the category of Fake, Fraud, Adhoc/Contractual appointment/ Migrant substitute and there is nothing adverse against the official(s) from VOK/Crime/ Police or any other agency.
- 5. The benefit of promotion/confirmation shall not be allowed in case of such official(s) who is/are either under suspension or whose suspension period is still undecided or against whom the departmental/VOK proceeding is presently pending.
- 6. Satisfactory Integrity/ Work & Conduct Certificate from the concerned Drawing and Disbursing Officer.
- 7. An affidavit duly executed before 1st Class Magistrate, to the effect that there is no Court case, investigation whatsoever nature pending before the Department or any investigating agency against the official(s).
- 8. Up-dated service verification certificate of each official.
- 9. Superior claim vis-à-vis inter-se-seniority of the officials for redetermination of seniority in the cadre of Head Assistant/ Section Officer, if any shall be submitted to this Directorate within a period of one month through proper channel.
