Sanction is hereby accorded to the temporary appointment of Mr **Asif Majeed Dar S/o Ab. Majeed Dar, (Deceased Master, GHS Rohama Rafiabab, Baramulla who died in harness on 21.08.2020) R/o Rohama District Baramulla, Qualification: 11th as MTS (Lab. Bearer), in the Pay Level- SL1 (14800-47100) against an available post of MTS (Direct quota) in District Baramulla, UT of J&K, on compassionate grounds under SRO-43 of 1994.**

The appointee shall report to the **Chief Education Officer Baramulla** within a period of **21 days** from the date of issuance of this Order and shall be allowed to join only on production of the following documents/certificates in original to be verified subsequently:

1. **Academic Qualification Certificate.**
2. **Date of Birth Certificate/ Matriculation Certificate.**
3. **Domicile Certificate issued by the competent authority.**
4. **Health Certificate from the concerned Chief Medical Officer of the District.**
5. **No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.**
6. **All other relevant documents as are required under SRO-43/1994.**

**The appointment of the candidate shall further be subject to the following conditions; that:**

- a. He shall give an undertaking in the shape of an affidavit to the effect that;
  - i. There is no criminal record against the appointee.
  - ii. If, on verification, genuineness of the qualification certificates/ Date of Birth/ Dependent Certificate and other certificates/ documents from the concerned issuing authority is/ are found fake/ forged, the appointment made shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/her.
- b. The salary of the appointee shall not be drawn and disbursed to him/her unless a satisfactory report in respect of (i) & (ii) above as well as **Fresh satisfactory Character and antecedents report** is received from the Competent Authority.
- c. The appointee shall be initially on probation for a period of two years.
- d. The appointment of the candidate shall be governed by the "New Pension Scheme" (NPS) as per SRO-400 of 2009, dated: 24-12-2009.
- e. If the appointee fails to join within a period of **21 days** from the date of issuance of this Order, the appointment order issued shall be deemed to have been cancelled ab-initio without any further notice.
- f. The appointment shall be subject to outcome of writ petition(s), if any, pending in any Competent Court/ Tribunal etc.
