Hassina Akthar (D/O Jamal Wagay) W/o Late Ali Mohd Lone, (deceased Head Teacher, MS Brenwar, Zone Chadoora, Budgam who died in harness on 25/01/2019 ) Qualification 9<sup>th</sup> R/o Bonen, Chadoora, District Budgam as MTS in the Pay Level -SL1 (14800-47100) against the available post of MTS (Direct Quota) in District Budgam, in terms of SRO-43 of 1994.**

The appointee shall report to the **Chief Education Officer Budgam** within a period of **21 days** from the date of issuance of this Order and shall be allowed to join only on production of the following documents/certificates in original to be verified subsequently:

- Academic Qualification Certificate.
- Date of Birth Certificate/ Matriculation Certificate.
- Domicile Certificate issued by the competent authority.
- Health Certificate from the concerned Chief Medical Officer of the District.
- No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
- All other relevant documents as are required under SRO-43/1994.

**The appointment of the candidate shall further be subject to the following conditions; that:**

- She shall give an undertaking in the shape of an affidavit to the effect that;
  - There is no criminal record against the appointee.
  - If, on verification, genuineness of the qualification certificates/ Date of Birth/ Dependent Certificate and other certificates/ documents from the concerned issuing authority is/ are found fake/ forged, the appointment made shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/her
- The salary of the appointee shall not be drawn and disbursed to him/her unless a satisfactory report in respect (i) & (ii) above as well as **fresh satisfactory Character and Antecedents report and unmarried certificate** is received from the Competent Authority.
- The appointee shall be initially on probation for a period of two years.
- The appointment of the candidate shall be governed by the "New Pension Scheme" (NPS) as per SRO-400 of 2009, dated: 24-12-2009.
- If the appointee fails to join within a period of 21 days from the date of issuance of this Order, the appointment order issued shall be deemed to have been cancelled ab-initio without any further notice.
- The appointment shall be subject to outcome of writ petition(s), if any, pending in any Competent Court/ Tribunal etc.
