He shall give an undertaking in the shape of an affidavit to the effect that; a.

There is no criminal record against the appointee.

- If, on verification, genuineness of the qualification certificates/ Date of Birth/ Dependent ίί. Certificate and other certificates/ documents from the concerned issuing authority is/ are found fake/ forged, the appointment made shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/her.
- The salary of the appointee shall not be drawn and disbursed to him/her unless a satisfactory report in respect of (i) & (ii) above as well as Fresh satisfactory Character and antecedents report received from the Competent Authority.

The appointee shall be initially on probation for a period of two years.

The appointment of the candidate shall be governed by the "New Pension Scheme" (NPS) as per SRO-400 of 2009, dated: 24-12-2009.

If the appointee fails to join within a period of 21 days from the date of issuance of this Order, the appointment order issued shall be deemed to have been cancelled ab-initio without any further
