Whereas, Principal Govt. College of Education (IASE) Srinagar vide Letter No. GCOE/IASE/24/3167 dated 24/12/2024 has requested to depute 100 untrained/ Post-graduate Teachers to undergo B. Ed (regular) course during session 2025 & 2026; and

Whereas, in response to this office letter No. DSEK/Estt-III/A/40/183 dated: 30/12/2024, the Chief Education Officers submitted their recommendations for deputation of untrained graduate/post-graduate teachers to undergo B. Ed (regular) course, session 2025 & 2026 and accordingly this office vide letter No. DSEK/Estt- III/A/TS/40/2024/0237 Dated: 10/02/2025 requested the Administrative department for conveying necessary approval/order in respect of 100 untrained graduate/post-graduate teachers for undergoing B.Ed Programme at Government College of Education, Institute of Advanced Studies in Education (IASE), Srinagar for the session 2025 & 2026 as per the district-wise break up allotted in proportion to the No. of untrained graduate/post-graduate teachers of the districts; and

Whereas, Administrative Department vide letter under reference, conveyed approval for deputation of 100 untrained/in service teachers (List Annexed herewith as Annexure A) for undergoing B.Ed Programme at Government College of Education, Institute of Advanced Studies in Education (IASE), Srinagar for the session 2025 & 2026;

Now therefore, in view of the approval conveyed by Administrative department vide letter No. Edu-NG K/95/2025-01-(7620853) Dated: 24/00/2025, sanction is hereby accorded to the deputation of 100 (One Hundred) in-service untrained Teachers to undergo B.Ed (Regular Course) at the Govt College of Education, (IASE) Srinagar during the session 2025 & 2026 as detailed in Annexure to this Order.

However the deputation shall be subject to the following conditions:-

- That the deputation is made without prejudice to due consideration of superior claim, if any reported;
- 2. That the deputee (untrained in-service teacher) has not been nominated for such training earlier;
- That none of the untrained teachers listed in the Annexure to this order holds un-regularized FAT/fake/fraudulent/un-regularized ReT/untransited to Teacher grade-II/ Un-regularized Migrant substitute status or is under suspension or is not inactive service. In the event of such an instance, if any detected on re-verification, the deputee shall not be relieved for the course;
- 4. That a deputee who may be working against long or short leave arrangement or against a lien post of migrant teacher shall not be relieved for the course;
- 5. That it shall be the responsibility of the concerned Chief Education Officer and the Head of Office/ Institution to verify the particulars of each deputee by reference to his/her service book and the original testimonials, before relieving him/ her for the course. He should also satisfy himself that the qualification/ date of 1st appointment/ adjustment/ promotion/ regularization as teacher/ Grade-II and other particulars as recorded in the deputation order are correct.
- The Chief Education Officers/Drawing and Disbursing Officers concerned shall ensure that the deputees who have acquired graduation during service/ honorarium period have been allowed to do so by the competent authority and leave whatever kind due has been sanctioned/ entered in the service records accordingly;
- 7. That in case any variation is found in the particulars and a deputee is found actually not eligible for such deputation the same shall be brought to the notice of this Directorate for clarification within seven days and no such Teacher shall be relieved for the course;
- 8. That the deputee Teachers shall require to join the B.Ed course at the college of Education, Srinagar by or before **15**th **March 2025.** A deputee who fails to report to the Principal, College of Education, Srinagar by the specified date shall forfeit his/her claim for deputation to B.Ed and the deputation in his/her favor shall be deemed to have been cancelled and the same shall invariably be recorded in their service records and their application for such deputation in future shall not be entertained;
- That the Chief Education Officers shall put in place an appropriate mechanism to make up for the gaps resulting in various schools as a result of this deputation order;
- 10. That the Chief Education Officer and DDO concerned shall implement the deputation order only after observing all the conditions as laid down herein above for deputation of these In- service Teachers for B.Ed Regular Course for the session 2025 & 2026

- 11. That the Principal, Govt. College of Education, IASE Srinagar shall furnish attendance/performance report of the in- service pupil Teachers to the Joint Director SCERT Srinagar enabling the Institute to help keep tabs on their progress/achievement during the Session. The SCERT in turn, shall Institute a suitable and effective monitoring mechanism for the purpose and put up periodical reports in the matter to this Office;
- 12. That the Chief Education Officers/ Drawing and Disbursing Officers shall implement the order after observing all the conditions as laid down herein above for deputation of in-service Teachers for B.Ed Regular Courses during the Session 2025 & 2026. It shall be the personal responsibility of concerned Chief Education Officers/Drawing and Disbursing Officers to clarify the observations indicated in the Annexure to this Office.

Before implementing the order it is responsibility of all the Chief Education Officers and DDO concern to ensure fulfillment of all formalities/conditions as laid down herein above. In case if any deputee is found registered for B.Ed through IGNOU/NIOS/Kashmir University (Distance Mode) in that case such deputee shall not be relieved for B.Ed deputation until further orders from this Directorate. Any complaint, if received in this behalf by this Directorate shall be viewed seriously.
