Whereas, the Chief Education Officer, Kulgam vide letter No. CEO/K/Estt/4353/23 dated:- 21/08/2023 forwarded the communication of Zonal Education officer, Kulgam dated:- 19/08/2023, wherein it was intimated that you have not resumed your duties after culmination of winter vacation 2022-23 and have remained un-authorizedly absent from w.e.f 01.03.2023; and

Whereas, you were provided enough opportunities by the DDO concerned to resume duties and were Show caused on 29/03/2023, 06/04/2023., 17/04/2023 and on 07/08/2023 but you failed to resume your duties; and

Whereas, the matter regarding your un-authorized absence was taken up with the Administrative Department vide this office communication No. DSEK/Estt/III/B-Trs/MZ/1217/021/10653 dated:- 06/11/2023 along with complete details of the case including the report on your previous un-authorized absence w.e.f 01/03/2021 to 27/07/2021 (which was later treated as leave without pay); and

Whereas, the Administrative Department vide communication No. Edu-NG K/14/2024-01 (CC No. 7381145) dated:- 20/03/2024 directed to take further necessary action in the matter in accordance with the Article 128 of J&K CSR Vol-I, which reads as under:-

“Absence without leave or after the end of leave involves loss of appointment”.

Now, therefore, through the medium of this Notice, one more opportunity is given to you for resumption of duties by joining in the office of Chief Education Officer, Kulgam within a period of **10 days** from the date of issuance of this notice, failing which it shall be presumed that you are no longer interested to continue your services, and action as warranted under rules shall follow without any further notice.
