**Subject: Issue of Lecturers deputed to UT of Ladakh- settlement of intervening period.**

Reference: Administrative Department's Communication No: Edu-Lect/161/ 2022-01 (7080274) dated: 18-02-2025.

**NOTICE**

**Whereas**, the General Administration Department vide Order No: 1294-JK(GAD) of 2021 Dated: 09-12-2021 deputed 63 Lecturers of School Education Department to UT of Ladakh with the direction to report General Administration Department, UT of Ladakh for further posting and were deemed to have been relieved from their places of postings in the said order; and

**Whereas**, the 09 Lecturers whose details are given in Annexure to this Notice, did not joined in the General Administration Department, UT of Ladakh within the prescribed time limit as provided under Rules; and

**Whereas**, the various Lecturers including the aforementioned 09 Lecturers were repatriated by the Govt. from the UT of Ladakh on different dates and subsequently were posted in the different institutions in UT of J&K vide this Directorate's Order No: 541-DSEK of 2022 dated: 16-11-2022; and

**Whereas**, this office received representation from these 09 Lecturers for deciding of intervening period (between relieving from UT of J&K and joining in UT of Ladakh) and in order to settle the said period, this office constituted committee vide Order No: 438-DSEK of 2022 Dated: 30-07-2022; and

**Whereas**, the recommendation of the committee as well as the relevant information/ documents with specific recommendations obtained from the concerned CEO's were submitted to the Administrative Department from time to time and latest on 14-10-2024; and

**Whereas**, the Administrative Department vide letter No: Edu-Lect/161/2022-01 (7080274) dated: 18-02-2025 has issued following instructions for settlement of intervening period of concerned lecturers:-

- I. A formal notice shall be issued to all concerned lecturers seeking detailed explanation regarding their whereabouts and activities during the intervening period between their relieving from UT of J&K and joining in UT of Ladakh.
- II. The lecturers shall be directed to furnish documentary evidence supporting their explanation.
- III. They shall be directed to submit an affidavit duly attested by a First-Class Magistrate, declaring that:

- c. They were not engaged in any activity unbecoming of a Civil Servant during the intervening period.
- d. They understand that any adverse facts emerge subsequently about this period shall make you liable for disciplinary action as warranted under rules.
- IV. The intervening period shall be adjusted against leave of whatever kind due in their leave account.
- V. In case of insufficient leave balance, the remaining period shall be treated as Leave without Pay (LWP).
- VI. The entire period shall be subject to the condition that nothing adverse is found against their conduct during this duration.

In view of the above, the 09 Lecturers whose details are given in annexure to this Notice are hereby directed to submit the reply alongwith documentary evidence duly authenticated by the concerned CEO/ affidavit to this Directorate through proper channel (viz. DDO/ CEO) within 15 Days from the date of issuance of this notice, failing which no claim / documents shall be entertained.
